Wetland Nos. W2, W3a, W3, W4, W5, W6, W6a, W7a, and W7b (totaling 27.1-acres) are in an isolated basin greater than 200 feet from a surface water and/or OHWM. Wetland 7 (totaling 5.9-acres) is Corps jurisdictional and hydrologically connected to Crystal Lake. Wetland areas are not navigable and there is no land use allowing a nexus to interstate commerce.
