This site is in the Shingle River drainage basin. Wetland areas that were determined to be isolated, with respect to Corps jurisdiction, and have no connection (natural or manmade) to waters of the United States. Further, these areas were more than 200 feet removed from any kind of drainage feature with surface water and/or an ordinary high water mark. The wetland areas are not navigable and on surrounding uplands, there does not appear to be a nexus to interstate commerce.
