**NEW PUBLIC NOTICE WEB SITE FOR JACKSONVILLE DISTRICT**

Beginning on/about June 1, 2004, the Jacksonville District Regulatory Division Public Notice web site will be revamped to better serve you. The following changes will be implemented at that time:

1. Public Notices will be published twice weekly on Mondays and Wednesdays. On Fridays and Tuesdays, you will receive an email with a detailed listing of the Public Notices to be published on the following Monday or Wednesday. This detailed listing will include much of the same information that you once received by email for each Public Notice and will include hotlinks. This listing will be sorted by county name to facilitate finding those you might be interested in, and will be further divided to separate regular permit application Public Notices from the Administrative Penalty Public and Special Issues Public Notices. Special Interest Public Notices do not involve a permit application, but instead are on general topics such as changes in our regulations, office closures, etc. We will no longer send out individual electronic notices for each public notice, nor will our listing allow us to limit your interests to a particular county or type of work, but this information will be clearly identified in the listing that you will receive twice a week.
2. The main Public Notice page will be redesigned to provide a block for each Monday and Wednesday publishing date. This page will also include links to the Administrative Appeals Page, and other appropriate links. Public Notices will be archived by date published for approximately 6 months on the web site. This is a new feature that we think you will find useful.
3. If you would like to be placed on a mailing list to receive an electronic copy of the public notice listings, please contact the Regulatory Division, U. S. Army Corps of Engineers, 701 San Marco Blvd., Room 372, Jacksonville, FL 32207-8175, or send your name, company name (if applicable), mailing address, telephone number and email address to Nancy Show at the email listed below. We would appreciate it if you would also indicate if you are a contractor or consultant. While this last bit of information is strictly voluntary on your part, it will help the Corps to keep you advised of procedural or regulatory changes regarding the Regulatory Program. If you have already provided the above information via form in the last 4 months, you do not need to provide again as we have your completed form on file. **Important:** It is your responsibility to notify us of any changes to your information, particularly the email address once the electronic notification is running. If the email address is incorrect through no fault of this office, public notice listings will not be forwarded electronically nor forwarded via regular mail.

**Privacy Policy:** The information you provide will be used solely for the purposes of forwarding Public Notice Listings requested by you and for our required official records by regulation (list of persons that Public Notices were forwarded to) (33 CFR Part 325.3(d)(3)).

**NOTE:** Due to budget cuts and escalating costs in processing and mailing of public notices, we are requiring email addresses and Internet access. Only under special circumstances will we send copies of the public notices via the U. S. Postal Service.
